## Disclaimer

However, Project V does not assume responsibility or liability for the health, safety, or actions of participants involved in the donation or exchange process. By participating, both Donors and Recipients agree to the following:

## 1. Voluntary Participation

Participation in the blood or life force donation process is entirely voluntary. By choosing to donate or receive blood or life force (energy), you confirm that you do so of your own free will, without external pressure, and may withdraw from the process at any time.

## 2. Health and Safety

Project V does not conduct or supervise medical or energetic procedures, health screenings, or testing for infectious diseases. Donors and Recipients are responsible for obtaining appropriate medical and energetic evaluations from licensed professionals prior to any donation.

### 3. Medical and Energetic Responsibility

Project V is not a medical or energetic service provider and does not offer medical or energetic advice. Concerns related to health, safety, compatibility, or suitability for blood or life force donation should be directed to qualified professionals. Both Donors and Recipients must ensure safe and sanitary handling of all materials used.

## 4. Confidentiality

Project V does not manage personal or health-related information exchanges. Any disclosure of private information is at the discretion of the individuals involved, and participants are encouraged to handle sensitive information with care.

## 5. No Compensation or Financial Involvement

Project V does not offer or facilitate compensation for donations. Any agreements regarding compensation are personal matters between the Donor and Recipient.

## 6. Limitation of Liability

Participants acknowledge that Project V is not liable for outcomes, injuries, infections, imbalances, complications, or legal matters arising from donation activities. Both Donors and Recipients agree to hold Project V harmless from any claims or disputes that may arise.

### 7. General Advisory

Participants are encouraged to prioritize health, balance, and safety by consulting healthcare or energetic professionals before engaging in any donation activities.

Addressing medical, legal, and personal considerations is crucial prior to participation.

## Preface

It is encouraged to have this printed out and stored in a safe place for you to refresh your memory on this agreement. That way if you are meeting up in person for these donorships you can bring out this form to bring awareness to the agreed boundaries.

WHEREAS, the Donor agrees to donate blood to the Recipient, who identifies as part of the vampire/sanguinarium community, for personal use.

NOW, THEREFORE, all the parties agree to the following:

## 1. Purpose of the Agreement

This Agreement establishes terms and conditions under which the Donor will provide blood/energy to the Recipient, ensuring a consensual, safe, and mutually beneficial process.

#### 2. Consent

All parties voluntarily consent to donate blood to the Recipient, free from coercion, and may withdraw consent at any time. The Recipient agrees to respect the Donor's right to withdraw consent at any point before or during the donation and visa versa.

## 3. Health and Safety Requirements

Health Screening: The Donor agrees to undergo a health screening by a licensed professional to ensure safety. The Recipient may also be required to undergo health screening as agreed.

Medical Examination: All Parties will provide accurate medical history and disclose any conditions that may affect safety.

Infectious Disease Testing: The Donor agrees to testing for infectious diseases (e.g., HIV, Hepatitis B and C). The Recipient may also provide proof of testing as agreed.

Sterilization and Equipment: The Recipient agrees to use only sterile equipment during collection, following all recommended procedures to prevent infection or injury.

Emergency Protocols: Both parties agree to have an emergency plan in place for addressing any medical issues during or after the donation.

## 4. Quantity and Frequency of Donation

The amount and frequency of blood donations shall be mutually agreed upon and will not exceed what is deemed safe by a medical professional.

## 5. Confidentiality

Both parties agree to maintain confidentiality regarding identities, health information, and any donation details, except as required by law.

## 6. Compensation

The donation is made voluntarily and without expectation of financial compensation. Any compensation provided will be documented within this Agreement.

## 7. Legal Considerations

Both parties acknowledge that they voluntarily enter into this Agreement with legal capacity. This Agreement complies with all applicable laws and regulations.

#### 8. Termination

Either party may terminate this Agreement at any time, for any reason, by providing written notice. Upon termination, no further donations will be made, and unused blood will be disposed of per health regulations.

## 9. Dispute Resolution

In the event of disputes arising from this Agreement, the parties agree to first attempt mediation. If mediation fails, disputes may be resolved through arbitration or legal action as necessary.

## 10. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the [State/Country] where the donation takes place.
